

LE JARRIER GITE - BOOKING CONDITIONS

1. Advertising and Accuracy

Whilst every effort has been made to ensure that the brochure / website and all advertising material is accurate at the time of publication, we cannot be held responsible for changes or matters outside our control. All information is given in good faith but no warranties are made regarding information provided, either written or oral.

2. Booking, Payment & Damages Deposit

Bookings can be made by E-mail and confirmed once the Booking Form supplied by the owner has been completed and returned by email to the owner of Le Jarrier Gite.

A deposit of 25% per booking (non refundable) will be required via Paypal. If you are booking less than 4 weeks before your arrival date, the full price.

Under no circumstances can the prescribed number of persons per booking form be exceeded.

Le Jarrier Gite is legally covered by insurance for up to four persons in addition to a baby in the travel cot.

The final payment becomes due four weeks before your holiday date. There will be no refund 21 days before arrival. If the full amount is not received by the due date we reserve the right to cancel the booking.

Upon your arrival at Le Jarrier Gite, we will require a £100 cash sterling or 110 euros as a Security / Damages deposit. This will be returned at the end of your stay, provided there has been no major damage or serious breakages to the property and its contents.

3. Prices

Prices are per week for Le Jarrier Gite and are inclusive of electricity, gas, water and the provision of bed linen and towels but do not include towels for use outside the cottage(s) or around the pool. Please bring your own pool towels.

4. Cancellation

It is recommended that you take out insurance to protect the risk of cancellation from the time of booking and for medical, baggage cover etc. whilst abroad. Should the gite be unavailable on the day stated, due to unforeseen circumstances, every attempt will be made to relocate guests. If this is not possible, all rent monies will be refunded without question but no further liability will fall upon the owners.

5. Your responsibilities - cleaning, damages & Arrival / Departure times

Your property - Le Jarrier Gite - will be cleaned before your arrival and we respectfully ask you to remember that you are staying in someone else's home and to leave it clean and tidy when you depart. We can only refund the deposit once the gite has been viewed on the morning of your departure.

We provide cleaning products such as a mop and bucket, Hoover and hand held cordless Hoover, floor cleaner, BBQ cleaner, shower and Kitchen cleaner, cloths, dusters and polish etc to ensure the property is left by you as you found it.

If additional cleaning is required, a minimum charge of 40 EUROS (cash) will be due to the owners.

However, if you prefer the owners to clean the property when you leave, a Cleaning Fee of 40 EUROS (cash) will be charged and will be payable to the owners on the day you depart.

Breakages should be reported to the owners in order that it can be rectified before the following clients arrive.

Please do not arrive at the property before 16.00 hrs and kindly leave by 10.00 a.m. on the day of departure (otherwise you could be charged extra rental) in order to give enough time between clients to ensure that the property is ready for others.

We ask that you kindly provide an approximate time of arrival on the Booking Form so we can make sure we are here to welcome you to Le Jarrier Gite.

6. Complaints

In the event of any complaint arising, either on arrival or after occupation has commenced, this should be brought to the attention of the owners immediately so that remedial action, where necessary, can be taken without delay.

The owners will do everything possible to deal with any difficulties both quickly and effectively. The owners also retain the right to enter the property at any reasonable time to deal with any complaints and to carry out any repairs deemed necessary to the property or equipment. Any complaint after departure must be in writing within 7 days of your departure.

7. Swimming Pool - Open late May to September - above ground 3.6 metres circular.

Pool towels not supplied - please bring your own towels for use with the pool. No swimming between 20.00 hours and 09.00 hours. No diving as the pool is only 1.2m deep. No drinking glasses or bottles to be used around the pool (plastic only please) or food (crisps etc).

Children must be under parent's supervision at all times as the owners cannot be responsible for their safety as there is no lifeguard on duty. For guests with younger children, there is a safety ladder which can easily be removed to prevent access to the pool by young children. Use of the pool is at the guests own risk.

8. General

Whilst every possible effort will be made to maintain the pool and household equipment in good order for the enjoyment of our guests we cannot accept liability in the event of any unforeseen problem, but would ask you to bear with us whilst we attempt to rectify the problem as soon as possible.

We accept smokers but would appreciate you smoking outside. If the gite needs to be fumigated due to excess smoke a minimum charge of 30 EUROS will be due. We do provide an external ash box for smokers and an ash tray only for use outside the property only.

We do not accept guests pets at the gite.

9. Car parking

There are two car parking spaces directly next to Le Jarrier Gite. These are allocated specifically to gite guests. Parking is at the car owners risk.
