## Terms of Temporary Tenancy –

### I accept:

1. That this is a temporary holiday letting for the period given above.
2. My party will avoid smoking in the gîte.
3. I will leave the gîte clean and tidy. Please arrive after 4pm on the day of occupancy and depart not later than 11am on the last day – for us to clean and change bedding if applicable.
4. The deposit and cancellation terms: 30% of rent non-refundable deposit is required to secure the booking. A £750 returnable deposit is required against breakages with the remainder of the booking fee. The remainder is due 4 weeks prior to occupancy otherwise the gîte may be re-let; to the remainder I will add £100 for a cleaner, if required. Booking confirmed when deposit and signed booking form is received. Fully confirmed when remainder of booking fee received. The returnable deposit will be returned by means of payment received to you when we have inspected the gîte after you have departed
5. That the owners accept no responsibility for personal loss or injury to any of my party however caused and will arrange my own holiday, personal accident and travel insurance. (The gîte itself and our French law ‘responsabilité civile’ is of course covered by us).
6. That if I bring any pets I will ensure that they do not cause any ongoing issues and will be cleaned up after.
