Booking Terms and Conditions

These terms and conditions apply to anyone hiring mobile home E24 or E25 at Les Amiaux, St. Jean de Monts, France.

Booking : A firm booking is made once we have received the completed booking form and the appropriate, non - refundable deposit of 25% of the total cost of the booking. An email will be sent as receipt and confirmation of the booking.

Payments: The balance of the rental will be due 6 weeks before the holiday. Booking made within 6 weeks of departure require full payment at time of booking.

Cancellations: The client will remain liable for the payment of the balance unless the owner can re let the home. We therefore recommend that you include holiday cancellation cover in your holiday insurance.

Security deposit: A refundable deposit of £ 200 will be required with your final payment. (This is best in the form of a separate cheque which I can then return to you)
This will be returned to you approximately 28 days after your return, provided the home has been left clean and tidy ready for the next visitors. If the home needs to be cleaned for the next clients, a percentage of this deposit will be used to cover cleaning costs. Any damage / breakages must be reported and an appropriate deduction can then be made from this security deposit.

Site Regulations: The hirer agrees to abide by the site rules and regulations, which are displayed at the entrance to the site, and to show consideration for the occupants of nearby homes.

Taxe de Sejour: This is payable by each occupant of the mobile home aged 18years or over. It is 0.61 euros per day per person. We are obliged to collect this from our clients and pay it to the site owner.

Liability: We do not accept any responsibility for any loss or damage to persons, or property or for any additional expenses incurred resulting from hire of our mobile home or the use of the equipment. In no circumstances shall the owners liability to the client exceed the amount paid to the owner for the rental period.

For this reason we advise the hirer to arrange suitable holiday insurance cover.
